KNOW ALL MEM BY THESE PRESENTS, That Water Improvement District No. 18, of Tulsa County, Oklahoma, a municipal corporation, for value received, hereby acknowledges itself indebted to and promises to pay to the bearer hereof the sum of One Thousand Dollars (\$1,000.00), on or before October 1, 1969, with interest thereon from date hereof at the rate of six percent per annum, payable on October 1, 1950, and semi-annually thereafter on the first day of April and October of each year until maturity of this bond, as provided by law, as evidenced by and upon surrender of the annexed interest coupons as they severally become due. Both principal and interest are payable in lawful money of the United States of America at the fiscal agency of the State of Oklahoma in the City of New York, State of New York.

This bond is one of a series of Water Improvement District Bonds, numbered in numerical order, issued in the manner and form prescribed by law pursuant to a resolution adopted by the Board of County Commissioners of Tulsa County, Oklahoma, and delivered for the purpose of paying the cost and expense of the construction of the public distribution of Water Improvement District No. 18 of Tulsa County, Oklahoma and is payable solely from assessments which have been regularly levied upon tracts, lots and parcels of land benefited by said public distribution system and from the accumulation of interest and penalties arising from said assessments, which assessments, interest and penalties, said Water Improvement District No. 18, Tulsa County, Oklahoma, undertakes to collect as by law provided, and the faith, credit, revenues and property of said Water Improvement District No. 18, Tulsa County, Oklahoma, are hereby irrevocably pledged for the purpose of carrying out each and every stipulation contained in this bond.

It is hereby declared and certified that all accounts, conditions and things required to do done and to exist precedent to and in the making of said improvements the levying of said assessments and the issuing of this series of bonds have been properly done, happened and performed, and do exist in regular and due form, time and manner, as required by the Constitution and laws of the State of Oklahoma and the total amount of said assessments and of the bonds issued on account of said improvements, including this bond, do not exceed any constitutional or statutory limitations.
