Pursuant to recess heretofore taken, the Board of County Commissioners re-convened at the hour of 2:00 o'clock P.M., with all members present: John H. Miller, Chairman;

J. B. Gray and Harry L. Hopkins, Members. Andy Stokes, Jounty Clerk.

Chairman Miller presiding, the following business was Transacted.

Reading of the minutes of the previous meeting was dispensed with and there being no objection to the same they were ordered to stand approved.

The following resolution was introduced by Commissioner Gray, who moved its adoption; said motion being seconded by Commissioner Hopkins. Chairman ordered the resolution read.

## RESOLUTION

Chris Garvis, et al, Defendants, for the sum of \$4,000.00 with interest at the rate of 6 per cent per annum from the 8th day of July, 1935, until paid, and for costs of said suit; and judgment was rendered in cause No. 60147 in the District Court of Tulsa County, Oklahoma, on the said 8th day of July, 1935, said cause being entitled State of Oklahoma ex rel, Holly L. Anderson, Co. Atty. Plaintiff, v.
