"Shall the Board of County Commissioners issue the negotiable coupon bonds of Tulsa County, State of Oklahoma in the sum of Two Hundred Fifty Thousand (\$250,000.00) Dollars to mature serially \$15,000 each year beginning 3 years from their date and \$10,000 in the 19th year and bearing interest not to exceed the rate of three per centum per annum, payable semi-annually for the purpose of constructing a bridge over the Arkansas River east of Jenks in Sections 19 and 20, Township 18 North, Range 13 East?"

THAT the Clerk of said county shall be and he is hereby authorized to cause to be published in the Farm and Garden, a weekly newspaper published and of general circulation in said county, proclamation of said election, said proclamation to be signed by the Chairman of said Board, attested by the County Clerk with the seal of said county affixed thereto and shall set out the date and purpose of the election, amount of bonds proposed to be issued, the length of time the bonds are to run, the rate of interest, the location of the bridge, the number and location of the polling places and the names of the judge and clerks for such precinct and the hours at which the polls shall be opened and closed.

SECTION 3.

The ballots used shall set out the proposition to be voted upon substantially as set out in Section 1 hereof and said election shall be conducted in the manner prescribed by law for such elections.
