Alan English, Larry Coulson, Jewell Wood and Jim Manzelmann presented a proposal to the Board for consideration with regard to the land at 51st and Hudson. The proposal for the "Tulsa Science Museum" was referred to the Park Board for review and consideration.

Motion by Rice, seconded by Harris, to approve and authorize execution by Chairman, the Contract between Tulsa River Parks Authority and Tulsa County Drainage

District 12 for joint financing of a maintenance facility to house both the River Parks

Authority maintenance crews and Drainage District 12 operations. Voting by a show of hands, Harris, yes; Rice, yes; Young, yes. Motion carried. (Clerk's Misc. File No. 103366)

A request from Jack Helton to purchase vehicles will be referred to the Board of County Commissioners Agenda for February 22, 1983.

The Operations Report of Administrative Services for 1982 was discussed.

The Board authorized Rice to detail a plan for the Bixby Senior Citizens Center.

Motion by Young, seconded by Rice, to adopt the Revenue Sharing public hearing calendar as proposed by Wayne Carr. Voting by a show of hands, Harris, yes; Rice, yes; Young, yes. Motion carried.

Helton memo regarding parking lot control will be held for future discussion.

A discussion was held regarding the disciplinary action procedure for Park employees. The Board will ask Terry Tallent to work up a basic policy for all Board Divisions for Board adoption.

A letter from Dave Faulkner requesting authority as a fully-commissioned peace officer will be referred to the Board of County Commissioners Agenda for February 22, 1983.
