The petitioner, the Tulsa Gas Pipe Line Company, respectfully represents and shows to your Honorable Board that it is a corporation, duly organized and existing under the laws of the State of Delaware for the purchase and transportation of natural gas; that in the conduct of its said business it will be necessary for it to run pipe lines for the transportation of natural gas across, along and under the public highways of Tulsa County, and more particularly as shown on the plat thereto attached, marked EXHIBIT "A" and made a part hereof.

As shown by said plat it is necessary that the petitioner in laying the said line pass under the concrete road between Sand Springs and Tulsa as shown by said plat. The petitioner in passing under said road will use a boring machine so that its operations will not in the least disturb the surface of the road nor its use at any time and will take all safe guards necessary to be done to preserve the security and the uninterrupted use of such road.
