

The Court of Common Pleas be held until such time as the Excise Board allows an Appropriation to cover same. Motion carried.

Motion was made by F.M.Wooden, seconded by Ira Short, that County Clerk be instructed to advise the County Attorney, County Assessor and Special Deputy State Examiner and Inspector that it is the desire of the Board that they meet in a special session in the office of the Commissioners on the 9th. day of April at the hour of ten o'clock A.M. The motion receiving the affirmative vote, was declared carried.

Motion was made by F.M.Wooden, seconded by Ira Short, that the County Clerk be instructed to advise Mr. T.L.Powell to be present at the special meeting of the Board of County Commissioners to be held on Monday, April 9th. 1923.

Motion was made by F.M.Wooden, seconded by Ira Short, that the letter of Wayne L.Dickey, County Treasurer, be and the same is hereby referred to the County Attorney for investigation and recommendation to this Board. All members voting in the affirmative, motion was declared carried.

Adjournment ordered until 2 o'clock PM.

Motion was made by F.M.Wooden, seconded by Ira Short, that the Cashier's Check in the sum of Five Hundred Dollars (\$500.00) now on deposit with the County Clerk, so deposited by Dahlstrom Improvement Company, as premium upon Drainage Assessment Bonds, be by the County Clerk deposited with the County Treasurer and by the County Treasurer held subject to further orders of this Board. Upon roll call all members voting in the affirmative, motion was declared carried.

On Motion of F.M.Wooden, seconded by Ira Short, the County Clerk is hereby instructed to return claim of James T.Whiteley with instructions to claimant to attach proper receipts for the items of expense appearing therein. Motion carried.

Orders were signed by the Chairman of the Board for the admittance of James Lampkins into the State Tuberculosis Sanatorium, at Boley, Oklahoma. Also, for the admittance of John Smith into the same sanatorium.
