Agreement was entered into that the Board of County Commissioners would receive plans and specifications for a twenty-four (24') foot Sub-Way, single track and also for a forty (40') foot Subway, double track. The Engineer's of the Missouri, Kansas and Texas are to prepare plans and specifications, as above set out, and are to have them ready for consideration of the Board on the 16th. day of April, or as soon thereafter as possible. An understanding was reached that the Railway Company is to pay for the cost of all construction work on their right of way, and the County of Tulsa will assume the cost off said right of way.

Motion was made by F.M.Wooden, seconded by Ira Short, that the claim of J.Rea Owen, in the amount of Two Thousand (\$2,000.00) Dollars, for the capture and conviction of Alvis Fears and Tom Cook be and the same is hereby approved. On roll call the following members voted "AYE" Geo.E.Gilmore, F.M.Wooden, and Ira Short. Nay, None.

At a meeting of the Board of County Commissioners of Tulsa County, held on the 4 day of April, 1923, the following Resolution was introduced by F.M.Wooden, who moved its adoption. The Motion was seconded by Ira Short, andupon roll call, was by the Chairman declared duly carried.

RESOLUTION.

WHEREAS, It is the opinion of this Board, that it is to the best interest of Tulsa County that Section "Q1" of the State Highway in Tulsa County be improved by grading and draining, and that Miles "la" and Miles "2a" of Section "Q" should be so improved.

NOW, THEREFORE, IT IS RESOLVED by this Board that the County Engineer be instructed to make the necessary surveys, plans and estimates, and to proceed with the work of grading, and draining the same, either by contract or volunteer subscription, convict or other day labor, or by force account.
