"RELEASE AGREEMENT"

KNOW ALL MEN BY THESE PRESENTS:

That,WHEREAS, on August 8th. 1921, the Aetna Casualty and Surety Company, executed Surety Bond #61046, coveringthe Producers National Bank as Principal, and running to the County Commissioners of Tulsa County,Oklahoma, covering funds of the County Treasurer on deposit in said Producers National Bank in the sum of Eighteen Thousand (\$18,000.00) Dollars, and whixh said bond has been continued in full force and effect until July 15th, 1930; and

WHEREAS ON SAID date the Fourth National Bank of Tulsa,Oklahoma, having been chartered and organized, took over and received all of the deposits of the Producers National Bank held by them for the account of the County Treasurer of Tulsa Tulsa County, Oklahoma, and said Treasurer of Tulsa County Oklahoma, receSved credit from the Fourth National Bank of Tulsa,Oklahoma on July 15th.1930 for the same amount which it had on deposit with the Producers National Bank, and

WHEREAS, the County Treasurer of Tulsa County Oklahoma, has received credit in the Fourth National Bank of Tulsa,Oklahoma for the same amount which it had on deposit with the Producers National Bank on said date, and

WHEREAS, a good and sufficient surty bond has been posted by the Fourth National Bank of Tulsa,Oklahoma to guarantee the deposits of the County Treasurer of Tulsa Oklahoma in that institution, and

WHEREAS, the County Treas. of Tulsa County,Oklahoma, has accepted the surety bond os posted by the Fourth National Bank of Tulsa,Oklahoma, under the arrangement with the said Fourh National Bank of Tulsa,Oklahoma,"with the Surety so furnished by it, and

WHEREAS, the County Treasurer of Tulsa County,Oklahoma, no longer has on deposit any funds with the Producers National Bank of Tulsa,Oklahoma, and has had no deposit with the said Producers National Bank since July 15th.1930, and

WHEREAS, there is no occasion for any further liability on the surety of the Producers National Bank's bond herein above described, and the said County Commissioners desire to release the surety of the Prdducers National Bank, namely, The Aetna Casualty & Surety Company from all liability on and under said bond, from and after July 15th.1930.

NOW, THEREFORE, for and in consideration of the sum of \$1.00 and other good and valuable consideration, the Board of County C mmissioners does herebyand by these presents release, discharge and forever hold free and harmless the said The Aetna Casualty and Surety Company of and from any and all liability to it on account of the Execution of Surety Bond #61046 under date of August 8th.1921, in the sum of \$18,000.00, from and after July 15th.1930.

It is inteded for the above consideration that The Aetna Casualty and surety Company be released, discharged and forever held free and harmless for an on account of any claim asserted arising after July 15th.1930.

That is to say, the Board of County Commissioners of Tulsa County,Oklahoma, are hereby agreeing tothe cancellation of the above referred to bond as of the date July 15th 1930, said Bond to be of no forde and effect after said date.
