MEMORANDUM OF CONTRACT.

This Contract made and entered into this 20th. day of June, 1921, by and between the Board of County Commissioners of Tulsa County, Oklahoma, party of the first part, and Wm.M.Gulager, party of the second part.

WITNESSETH: That said Board of County Commissioners shave hereby contracted with the said Wm.M.Gulager, as provided by Section No. 7449 of the Revised Laws of Oklahoma, 1910, to assist the proper officers in the discovery of property omitted from assessment and taxation.

The terms of this Contract are to extend for a period of two years from this day, June 20th. 1921, and said Wm.M.Gulager's compensation is fixed at Fifteen (15%) per cent of all taxes reported and collected as the result of his labor. Said compensation to be paid to Wm.M.Gulager as the law directs in the premises, after the collection of any such tax. It is further agreed that said W.M.Gulager shall conduct all necessary investigations and litigations at his own expense, and that the Board of County Commissioners shall not make similar contract with any other party or parties for the discovery of omitted properties in this County, during the life of this Contract, and that said Tulsa County is to be held harmless from all costs in any litigation that may arise, save and except furnishing the necessary postage, printing and records for the performance of his duties under this contract.

Motion was made by F.M.Wooden, seconded by Ira Short, that the plans and specifications, as prepared by John Duke for the construction of Cattle Barns at the County Farm, be and the same are hereby approved, and the County Clerk is hereby instructed to advertise for bids to be opened on Monday, April 23rd. 1923, at the hour of 10:00 o'clock A.M.

There being nothing further to come before the Board at this time, same was ordered adjourned to meet upon the call of the Secretary.
