WHEREAS, it is necessary for Tulsa County Drainage District No. 12, of Tulsa County, Oklahoma, to cause to be issued and sold, forty-five, One Thousand Dollar Coupon Bonds, in order to make available necessary funds to enable said Drainage District to conform with and complete its share and obligation of co-operative agreement with the War Department of the United States of America, in building a system of levees, drains and ditches, to prevent injury and damage from flood waters of the Arkansas River, within said Drainage District area; and,
