IT IS THEREFORE ORDERED BY THE BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY, STATE OF OKIAHOMA, THAT authority and permission is hereby given and granted to Sand Springs Railway Company, an Oklahoma railway corporation, to occupy the following described County road and public highway situate in Tulsa County, State of Oklahoma, to-wit:

The Section Line Road, or County Road, or highway lying on and along the section line between the Southwest Quarter of Section Twelve (12), and Lots Three (3) and Four (4), being the Northwest Quarter of Section Thirteen (13), all in Township Nineteen (19) North, Range Eleven (11) East, according to the United States Survey thereof,

for the location of it's railway tracks, poles, lines, trolley system and equipment for railway purposes. SUBJECT HOWEVER, to the agreement on the part of Sand Springs Railway Company that if said highway be improved by Tulsa County, that said Sand Springs Railway Company wkll adjust it's tracks and railway equipment so as to conform to any and all grades that may be established and subject to the further provision and agreement on the part of Sand Springs Railway Company that if, in the judgment of the Board of County Commissioners of Tulsa County, Oklahoma, it becomes necessary hereafter to widen said highway that Sand Springs Railway Company will at it's own expense procure additional land North and adjacent to said highway for the widening thereof, as may be found necessary. PROVIDED HOWEVER, that the Northern boundary line of said additional land to be procured and added for the widening of said highway shall not exceed at any point fifty (50') feet North of the section line dividing the Southwest Quarter of Section (12), and the Northwest Quarter of Section thirteen (13), all in Township Nineteen (19) North, Range Twelve (12) East, Tulsa County, Oklahoma.
