MINUTES THURSDAY, APRIL 3, 1986

The Board of County Commissioners for Tulsa County, Oklahoma met at the hour of 9:00 a.m., with the following members present: John Selph, Chairman; Melvin C. Rice, Member; Lewis Harris, Member. Members absent: none. Others present: Clayton Edwards; Melody Bishop; Mr. Ken Wolven of Governmental Data Systems; Harmon Moore, Barbara Rossetti, and Bobby Maxville, all with the Tulsa County Election Board; and Mark Lyons, Assistant District Attorney.

John Selph, Chairman, presiding, called the special meeting to order at 9:00 a.m., and stated the purpose of this special meeting is to discuss the up-grading of the Election Board voting system.

Wolven stated he requested this meeting with the Board of County Commissioners regarding the payment due to Governmental Data Systems under the Tulsa County Contract He feels GDS is in compliance and should receive payment.
