At the request of the Chairman, sealed bids on Project No. 3-I, improvement of Sheridan Road from 11th Street to 31st Street, were opened. Layman & Company's bid, in the amount of \$29,451.63, and their bid check for \$1,500.00; Standard Paving Company's bid, in the amount of \$29,270.11, and their bid check in the amount of \$1,500.00. Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried, that the bids be turned over to the County Engineer for his compilation and recommendation.

Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried, that the following Application be, and the same is hereby approved:

TO THE BOARD OF COUNTY COMMISSIONERS TULSA COUNTY, OKLAHOMA:

The undersigned hereby request permission and authorization from your Board to construct certain water lines in public roads or highways outside of corporate cities or towns in Tulsa County, Oklahoma, as shown in the plat which is hereto attached and made a part of this application; the location of the proposed water lines being more particularly described as follows, to-wit:

A 2-inch Galvanized Iron Water Main on Delaware Place from the South Line of 28th Street to the South Line of 29th Street, thence East on 29th Street to the West Line of Evanston Avenue. Approximately 777 L.F. of 2-inch Cast Iron Pipe.

It is understood and agreed that said permission and authorization, if granted, shall be subject to the following provisions which are hereby agreed to by applicant:

- 1. Permanent markers shall be placed by the applicant showing the location of said water lines.
- 2. The applicant agrees to maintain and keep in good repair the said water lines until such time as the land on which they are located is annexted to the City of Tulsa.
- 3. The applicant hereby relieves the Board of County Commissioners of Tulsa County, Oklahoma, of and from any liability for injury to said water lines in connection with work on the roads performed by or under the authority of said Board of County Commissioners.
- 4. Applicant agrees that the said water lines shall not interfere with the use or maintenance of the public roads.
