## MONDAY, OCTOBER 4th, 1937.

The Board of County Commissioners met in regular session on Monday, October 4th, 1937, at the hour of 10:00 o'clock A.M., with all members present: John H. Miller, Chairman; J. B. Gray and Harry L. Hopkins, members. Andy Stokes, County Clerk.

Chairman Miller presiding, the following business was transacted.

Reading of the minutes of the previous meeting was dispensed with and there being no objection to the same they were ordered to stand approved.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that \$2,500 be allocated to the Welfare Department for the month of October, 1937, for groceries. Upon roll call, the following vote was taken: Miller, Yes; Gray, Yes; Hopkins, Yes. Motion carried.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that \$3,000 be allocated for hospitalization for the month of October, 1937; same to be divided and allocated as follows: Morningside Hospital \$1,700; Sisler Hospital \$900; St. Johns' Hospital \$100; Tulsa General Hospital \$100; Poole Hospital \$100, and Flower Hospital \$100. Upon roll call, the following vote was taken: Miller, Yes; Gray, Yes; Hopkins, Yes. Motion carried.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that the following amounts be allocated to the following for drugs and supplies for the month of October, 1937: Red Fork \$30.00; Sperry \$25.00; Skiatook \$10.00; Sr. Smith \$50.00; Sand Springs \$25.00; Collinsville \$50.00; Bixby \$50.00; Broken Arrow \$50.00; Jenks \$25.00; Dr. Motley \$75.00; Dr. Barham \$150.00; Dr. Roberts \$50.00; Dr. McGuire \$5.00; Dr. Roberts for the jail \$100.00; for the clinic \$100.00. To the various drugs stores for prescriptions, to be divided as follows: Dr. Roberts \$100.00; Dr. McGuire \$25.00; Dr. Motley \$50.00; Dr. Barham \$225.00. To Dr. Childs \$60.00 is allocated and to Dr. Hairston \$40.00. Upon roll call, the following vote was taken: Miller, Yes; Gray, Yes; Hopkins, Yes. Motion carried.

A sealed bid on Lots 5 and 6, Block 12, Berry Addition to the City of Tulsa, Tulsa County, Oklahoma, according to the recorded plat thereof, was opened. Said bid was in the sum of \$75.00 and was made by E. S. Cooksey, signed by W. L. Eagleton, his agent. Motion by Commissioner Hopkins, seconded by Commissioner Gray, that said bid and other papers pertaining to said sale be referred to the County Attorney with a letter asking for his opinion as to whether ob not the County Commissioners are authorized to sell said lots. Upon roll call, the following vote was taken: Miller, Yes; Gray, Yes; Hopkins, Yes. Motion carried.

Motion by Commissioner Hopkins, seconded by Commissioner Gray, that the report filed by Andy Stokes, County Clerk, for the month of September, 1937, be and the same is hereby accepted and filed. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.
