RESOLUTION OF WAIVER AND DISCLAIMER
BY THE BOARD OF COUNTY COMMISSIONERS

Now, on this the 29th day of May, 1950, there comes on for hearing before the Board of County Commissioners of Tulsa County, State of Oklahoma, the petition of Walter Thomas Worthington and Lillian Worthington, residents of the City of Tulsa, Tulsa County, Oklahoma, which petition prays that the Board relinquish, waive and disclaim any interest in and to the following described land, to-wit:

North 30 feet of the North Half of North Half
of Southwest Quarter of Northwest Quarter
(N/2 N/2 SW/4 NW/4) of Section 28, Township 20
North, Range 13 East, Tulsa County, Oklahoma;

And it appearing that the allegations of the said petition are true and correct, and that the land described above is not now nor ever has been used as a public road;
