Pursuant to recess heretofore taken, the Board of County Commissioners re-convened at the hour of 10:00 o'clock A.M., with all members present: John H. Miller, Chairman; J. B. Gray and Harry L. Hopkins, members. Andy Stokes, County Clerk.

Chairman Miller presiding, the following business was transacted.

Reading of the minutes of the previous meeting was dispensed with and there being no objection to the same they were ordered to stand approved.

Motion by Commissioner Hopkins, seconded by Commissioner Gray, that the affidavits of erroneous assessment covering real estate belonging to the heirs of Rollie Sarty, deceased, for the years from 1910 to 1930, Inc., be and the are hereby approved and the County Clerk is directed to issue a certificate of error on said property. All members voting in the affirmative, motion was by the Chairman declared carried.
