For and in the consideration of the sum of One Dollar,(\$1.00) cash in them in hand paid, receipt of which is hereby acknowledged, Tulsa County, Oklahoma, by its Board of County Commissioners ,party of the first part, does hereby grant that the Tulsa Free Fair Association, as created in House Bill No.183, Session Laws of Oklahoma of the year 1915, to have and to hold, the right-of-way to consturct, repair, alter, maintain, renew and operate a race track cn, over and through the land of the party of the First Part, situated in the county of Tulsa, and State of Oklahoma, and described as follows, to-wit:

Beginning at a paoint 1988 feet North, and 901.25 feet East, of the S.W. Corner, section 32, Twp 20 North, Rge 13, East, running a distance of 600 feet, thence North 875.8 feet to the South Right of way line of the S.L.S.F.R.R., thence in a South westerly direction along said right-of-way line a distance of 653.28 feet, thence South 619 feet, to place of beginning containing 10.28 acres, more or less/

So long as the Tulsa County Free Fair Association continues to use the said above right of way for purposes above described. If said Tulsa Free Fair Association at any time ceases to exist or said right-of-way is used for other purposes than those herein described this contract becomes null and void and said property reverts to said grantors.
