Motion was made by J S Shaver, seconded by Ed W Hedgecock, that the County Clerk be instructed to spread \$1000.00 for Maintenance against Frye Drainage District, and also \$1000.00 against Park View Drainage District No. 2, for Maintenance. Carried.

Motion was made by W L North, seconded by J S Shaver, that Claim No. 104191 favor of Palace Office Supply Co. be allowed in the amount of \$39.00 Carried, as also Claim No. 104096, favor of James Harrington, be allowed in the amount of \$9.23.Carried.

At a meeting of the Board of County Commissioners of Tulsa County, Oklahoma held on the 21st. day of Sept. 1925, the following Resolution was introduced by W L North who moved its adoption:
