WHEREAS, for the purpose of constructing a highway thru and across a certain parcel of land in Section Thirty One (31) Township Nineteen (19) North, Range Twelve (12) East, Tulsa, Oklahoma it is necessary to acquire an EASEMENT across said parcel of land more particularly described as follows:

"A strip of land seventy (70') feet wide for right of way for highway purposes in the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Sec. 31, T 19 N., R 12 E., Tulsa County, Oklahoma, described as follows: Beg. at a point on the E. line of the said NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Sec. 31, said point being 420.4 feet S. of the NE corner of said tract; thence S. along the said E. line of the tract 72.6 feet to a point; thence N. 74° -39' W., 845 feet, more or less, to a point of a curve to the right; thence along said curve to the right with a radius of 989.9 feet, 417.9 feet to the point of tangent to the curve; thence N. 50° -29' W along the tangent to the curve 89 feet to a point on the S. line of the County road right of way; thence E. along the S. line of the road right of way, parallel to and 24.75 feet S. of the N. line of Sec. 31 110.2 feet to a point; thence S. 50° -29' E., 4 feet to the point of a curve to the left; thence along the said curve to the left with a radius of 919.9 feet 387.7 feet to the point of tangent to the curve; thence S. 74° -39' E. along tangent to the curve 826 feet, more or less, to the point of beginning the strip containing 2.07 acres, more or less".
