Monday, April 7th, 1913.

The Board of County Commissioners met in their Room at 9:30 A. M. Monday, April 7th, A.D. 1913; All members present and proceeded to audit claims against the County.

Upon motion, the following resolution was approved; all members voting "aye".

"BE IT RESOLVED, By the Board of County Commissioners of the County of Tulsa, of the State of Oklahoma, that

WHEREAS, the said Board of County Commissioners desire to enter into a contract with one S. A. Orcutt, for himself, and as guardian of Lela Orcutt, a minor, for the construction of a certain ditch along certain property belonging to said S. A. Orcutt and said Lela Orcutt, a minor, a copy of said contract being hereto attached, and made a part of this resolution,

NOW, THEREFORE, BE IT RESOLVED, that the said Commissioners are hereby authorized and instructed to enter into said contract, and to do any and all things necessary in connection therewith as in their judgment shall seem fit and proper."

A G R E E M E N T .

THIS AGREEMENT, Made this 7th day of April, 1913, by and between THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF TULSA, State of Oklahoma, of the first part, and S. A. Orcutt, for himself, and as guardian of Lela Orcutt, a minor, party of the second part, witnesseth:

That, WHEREAS, S. A. Orcutt is the owner of the following described premises, to-wit:

West Half (W/2) of Southeast Quarter (SE/4), being Lots Five (5) and Eight (8), and the West Half (W/2) of the West Half (W/2) of the Northeast Quarter (NE/4) of the Southeast Quarter (SE/4) of Section Thirty-six (36), Township Nineteen (19) North, Range Twelve (12), East, containing eighty (80) acres, more or less, and

WHEREAS, Lela Orcutt is the owner of the following described premises, to-wit:

Southeast Quarter (SE/4) of the Southeast Quarter (SE/4) and the East Half (E/2) of the Northeast Quarter (NE/4) of the Southeast Quarter (SE/4), and the East Half (E/2) of the West Half (W/2) of the Southeast Quarter (SE/4) of Section Thirty-six (36), Township Nineteen (19), North, Range Twelve (12), East, containing seventy (70) acres, more or less, and

WHEREAS, S. A. Orcutt is the legal guardian of said Lela Orcutt, a minor, and

Whereas, It is the desire of the said Board of County Commissioners to run a certain drainage ditch along the south line of the above described premises, the length of said ditch along said premises not to exceed eighty (80) rods;

NOW THEREFORE, It is agreed by and between the parties hereto that for and in consideration of the sum of Three Hundred Dollars (\$300.00), to be paid by the party of the first part to the party of the second part on or before the seventh day of April, 1913, and in consideration of the further covenants of first party hereinafter set forth, said second party agrees that, for the purposes of said ditch, there may be used a strip of land of the south side of the above described premises, not to exceed fifteen (15) feet in width and eighty (80) rods in length.

Said first party agrees to open the section line running along the south line of said premises for the full length of said premises to construct thereon a good and sufficient road for ordinary travel, and to build a bridge across said ditch, after the same is constructed, to the premises of second party, at a point to be designated by said second party, and first party further agrees to replace second party's fence in as good condition as the same now is, at its expense, and to level all dirt so that not more than the foregoing described strip is used or injured by the construction of said ditch.
