CONTRACT.

THIS CONTRACT AND AGREEMENT, Made on this 5th.day of December, 1932, by and between the BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY, OKLAHOMA, PARTY of the first part and W P BAKER, of Tulsa Oklahoma, party of the second Part.

WITNESSETH: THAT the Party of the Second Part, for and in consideration of the payment, or payments hereinafter specified and agreed to by the party of the first part, hereby covenants and agrees to furnish and deliver all materials and do and perform all the work and labor in the MOVING of a five room house, consisting of one log room and four frame rooms, with front porch, from its present location in the Work of NEth of Sec. 27 T 20 N., R 13 E., to a new location agreed upon between the said Second Party and Mrs.E.P. Lewis; said new location to be approximately 150 feet north and 150 feet East of the present site of house, in the St of SWt of SEt of Sec. 22, T 20 N., R 13 E.

The party of the Second Part hereby covenants and agrees that all and every part of said work shall be done in the best and most workmanlike manner, to the satisfaction of the Owner, Mrs.E.P.Lewis, and the house shall be re-set on an 8" x 1' solid concrete foundation base with three (3) rows of concrete blocks on top.
