With reference to the Big Four Paving Company, this company has completed five and one eighth (5 1/8) miles, leaving three and seven eighths (3 7/8) miles to complete on their original nine (9) miles contract.

Believeing that additional time should reightfilly be extended with application of the penalty, and as their time should be up, January 1st, 1921, as provided for in extension given them as approved by you on July 7th, 1920, it is hereby recommended to you that this time be advanced to August 1st, 1921, without penalty.
