WHEREAS, it is impossible because of lack of facilities for the Juvenile Court of Tulsa, County, Oklahoma, to place said boys under proper supervision.

NOW, THEREFORE, BE IT RESOLVED, That the Judge of the Juvenile Court of Tulsa County, Oklahoma, be and he is hereby authorized to place said delinquent boys on the County Farm of Tulsa County, Oklahoma, under the care and supervision of the Manager of said farm, until other and further arrangements can be made.
