In Re - Plan of Readjustment
of Bonded Indebtedness of
Incorporated Town of Buffalo,
Harper County, Oklahoma.

R E S O L U T I O N

WHEREAS, under date of the 6th day of May, 1935, the Board of County Commissioners, legally and regularly assembled and convened, passed a certain resolution accepting the terms and conditions of a plan of readjustment and settlement of the bonded indebtedness of the Town of Buffalo, Harper County, Oklahoma, as outlined and described in Resolution 96, passed and approved by the Board of Trustees of the Incorporated Town of Buffalo, Harper County, Oklahoma, on the 8th day of February, 1933; and

WHEREAS, after a hearing before the United States District Court for the Western District of Oklahoma, it was adjudged and determined that said plan of debt readjustment was unfair and thereafter said Board of Trustees of the Incorporated Town of Buffalo, Harper County, Oklahoma, asked and secured leave to file an amended plan, offering to the creditors of said town thirty-three and one-third per cent (33 1/3%) of the total amount due by reason of principal and interest; and, whereas, the Board of County Commissioners of Tulsa County deems such proposal fair and is willing to accept the same;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Tulsa County, Oklahoma:

That said amended plan of debt readjustment be accepted and the Chairman and the Treasurer of Tulsa County, Oklahoma, be authorized to take all necessary steps to file proof of debt and acceptance of plan and said offer, and such other and further steps as may be required to consummate the terms and conditions thereof.
