RESOLUTION

WHEREAS, the Highway Department is in need of a Tractor, equipped with Mower, and has found that, the Ramsey Motor Company, has an Allis-Chalmers Tractor equipped with Mower, and that said Allis-Chalmers Tractor and Mower can be purchased by the Highway Department, from the Ramsey Motor Company, for a consideration of One thousand three hundred fifty seven Dollars (\$1,357.00).

NOW, THEREFORE BE IT RESOLVED, That the Chairman of the Board of County Commissioners be authorized to purchase said Allis-Chalmers Tractor, and the County Highway Department be authorized to draw a claim to the Ramsey Motor Company, in the sum of One thousand three hundred fifty seven Dollars, payable from Account Number 6-B, designated as "Highway Equipment" of the County Highway Department Account of General Fund.
