ASSESSMENT RESOLUTION
WATER IMPROVEMENT DISTRICT NO. 19

WHEREAS, the Board of County Commissioners did set a time for holding a session to hear and consider any complaints or objections concerning the appraisalment and apportionment of the costs of construction of the Public Distribution System in WATER IMPROVEMENT DISTRICT NO. 19 of Tulsa County, Oklahoma, and the proposed assessments therefor, and caused notice of such session to be published according to law and in pursuance of such action and publication, such session has been duly convened and held by the Board of County Commissioners of Tulsa County, Oklahoma, on the 19th day of June, 1950; and

WHEREAS, the Board of County Commissioners has heard and considered the complaints and objections of Dora Wilcox and Thomas R. Lindsay to said appraisalment and apportionment and reviewed the same, and

WHEREAS, all legal requirements have been fully complied with to authorize the levy and assessment to pay the cost of said improvement.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Tulsa County, Oklahoma, that there shall be and there is hereby levied and assessed against the several tracts, lots, and parcels of land in said WATER IMPROVEMENT DISTRICT NO. 19 as benefited the amounts respectively, as stated in the report of the appraisers, as amended, and which is levied and confirmed as follows:

R E S O L U T I O N

BE IT RESOLVED that the Board of County Commissioners of Tulsa County, Oklahoma, does hereby relinquish all right, title or interest the said Tulsa County may have acquired by virtue of a certain easement deed on file in the office of the County Clerk of Tulsa County, Oklahoma, and recorded in the Deed Records in Book 1912, at page 383 therein, insofar as same covers:

S $\frac{1}{2}$ of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 31, Township
21 North, Range 13 East; and the
N $\frac{1}{2}$ of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 31, Township
21 North, Range 13 East, Tulsa County, Oklahoma,

which said easement deed was executed by parties other than the owners thereof, except that Tulsa County claims an easement for road purposes to a strip 30 feet wide along the west side of said tract of land and a strip 30 feet wide along the east side of said tract; which Tulsa County specifically reserves.
