bridge for all proper public purposes, and

WHEREAS, the Public Service Company desires to use said bridge for the purpose of attaching certain of its cables thereof,

NOW THEREFORE, the Public Service Company shall be given the privilege of maintaining such cables as it may at this time find necessary to place upon said bridge, and any cable s which it may hereafter desire to attach thereto.

The Public Service Company shall pay to the County of Tulsa for the use of said bridge for the purpose aforesaid the sum of Twenty-five and No/100 \$25.00) Dollars per year for every cable which it may attach to said bridge. The rental referred to in this contract to be paid to the County Clerk of Tulsa County, quarterly in advance, beginning with the date of said attachment.

The cables to be so placed upon said bridge by the Public Service Company shall be so attached and maintained as not to discommode the public in the use of said bridge. Should the county Commissioners during the life of this agreement abandon said bridge, then said Public Service Company shall have the same right on any bridge constructed by said County Commissioners across the said Arkansas River, but the Public Service Company shall bear all expense or removing its cables to such new location.

This contract shall be in full force and effect from the date of execution thereof.
