The Board of County Commissioners met in the District Court room, Division No. 2, at the hour of 10:30 o'clock A.M., and the District Court convened for the special purpose of administering the Oath of Office to the new Board of County Commissioners. The new members, G. H. Shepard, Ralsa F. Morley and Lincoln Sallee, were sworn in by Judge Oras A. Shaw at the hour of 10:30 o'clock A.M. All members now being qualified as required by law, the District Court recessed and the court room turned over to the Commission for their first regular meeting.

The first business coming on for consideration of the Board was the appointment of a Chairman.

Motion by Commissioner Morley, seconded by Commissioner Sallee, that G. H. Shepard be appointed Chairman for the fiscal year 1939-40. Upon roll call, the following vote was taken: Morley, Aye; Sallee, Aye; Shepard, Aye. Motion carried.

G. H. Shepard, Chairman presiding, the following business was transacted.

Motion by Commissioner Morley, seconded by Commissioner Sallee, that the amount of the County Treasurer's bond be fixed at \$100,000.00. Upon roll call, the following vote was taken: Shepard, Aye; Morley, Aye; Sallee, Aye. Motion carried.

Motion by Commissioner Morley, seconded by Commissioner Sallee, that the bond filed by Joe T. Parkinson, County Treasurer, in the amount of \$100,000.00 and made by the Maryland Casualty Company, be and the same is hereby approved. Upon roll call, the following vote was taken: Shepard, Aye; Morley, Aye; Sallee, Aye. Motion carried.

Motion by Commissioner Sallee, seconded by Commissioner Morley, that the following appointments by Joe T. Parkinson, County Treasurer, be confirmed and their bonds and salaries be fixed as set out opposite each name, to-wit:
