A resolution authorizing PRODUCERS OIL COMPANY to construct and maintain a four inch water pipe line upon the public road between townships Seventeen (17) North and Eighteen (18) North in Tulsa County, Oklahoma.

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF the County of Tulsa, State of Oklahoma.

FIRST: That Producers Oil Company be, and is hereby authorized to construct, maintain and operate a four inch water pipe line upon the public road between Townships Seventeen (17) North and Eighteen (18) North in Tulsa County, Oklahoma, subject to the conditions hereinafter contained in this resolution.

SECOND: Said pipe line shall be located as near as practicable,, approximately as follows, to-wit:

Commencing at the Southwest corner of the intersection of the public road running east and west between township Seventeen (17) North and township Eighteen (18) North with the public road running north and south between Sections 32 and 33, township eighteen (18) North, Range Twelve (12) East and Sections 4 and 5, Township Seventeen (17) North, Range twelve (12) East, running thence in a northerly direction across said intersection to the northly direction across said intersection to the north side of the road and thence east along the north side of the road and thence east along the north side of said public road between townships Seventeen (17) North and Eighteen (18) North to the Arkansas river.

THIRD: Said pipe line shall be located within a distance of Four (4) feet from the north line of said road; shall be buried below plow depth and so operated and maintained as not to interfere with the use of said public road. All ditches shall be carefully refilled and where the line crosses any intereseting road the same shall be tamped so as to restore the roadway and leave the same in good condition.
