BE IT RESOLVED that the Board of County Commissioners of Tulsa County, Oklahoma, approves an agreement submitted by officials of the Missouri-Kansas-Texas Railroad Company, which proposed agreement is substantially as follows:

- "THIS AGREEMENT, made and entered into this 26th day of June, 1950, by and between the County of Tulsa, State of Oklahoma, by and through its Board of County Commissioners, hereinafter referred to as the "County", party of the first part, and the Missouri-Kansas-Texas Railroad Company, a corporation, hereinafter referred to as the "Railroad Company", party of the second part: WITNESSETH:
- "WHEREAS, by a certain written contract dated October 6, 1931, between the County of Tulsa, State of Oklahoma, acting by and through its Board of County Commissioners, and the Missouri-Kansas-Texas Railroad Company, a corporation, it was agreed that the Railroad Company's pile and timber bridge, No. Z-282.2, over a certain highway in Tulsa County known as Yale Avenue, should be re-arranged and re-constructed as therein provided, which agreement was approved by the Corporation Commission of Oklahoma in Cause No. 10908, by Journal Entry No. 2011 dated October 15, 1931, reference to which agreement and journal entry is hereby made, and said bridge was thereafter re-constructed in accordance with said agreement, and WHEREAS, it has now
