

O R D E R

WHEREAS, The Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to Chas. Bonchosky, the record owner of the lot hereinafter described, of a deed conveying to him for a consideration of One & 58/100 (\$1.58) the following described lot hereinafter described, to-wit:

Lot 4, Block 23, Town of Alsuma.

AND, WHEREAS, the sale of said lot by the County Treasurer was made pursuant to Section 9745 of the Compiled Oklahoma Statutes of 1921 as amended by Chapter 123 of the Session Laws of Oklahoma for 1923, whereby the County Treasurer is authorized to sell lands and lots purchased for the County by him as Tax resale; and

WHEREAS, due notice has been given and published by the County Treasurer in the Skiatook News, the official paper of the County of Tulsa, that the County Treasurer would on this date apply to the Board of County Commissioners for an order approving said sale, and directing the issuance of deed therefore, and
