R E S O L U T I O N

A RESOLUTION REPEALING AND REVOKING A CERTAIN RESOLUTION PASSED BY THIS BOARD ON THE 21 DAY OF OCTOBER 1946 ENTITLED "A RESOLUTION AUTHORIZING AND DIRECTING THE CALLING OF AN ELECTION FOR THE PURPOSE OF VOTING UPON THE QUESTION OF THE ISSUANCE OF THE NEGOTIABLE COUPON BONDS OF TULSA COUNTY, STATE OF OKLAHOMA, FOR THE PRUPOSE OF PROVIDING FUNDS FOR THE PURPOSE OF CONSTRUCTING A BRIDGE."

WHEREAS this Board of County Commissioners on the 21st day of October, 1946 passed a resolution authorizing and directing the Chairman of said Board to call an election in said county to be held on the 26th day of November, 1946 on the question of the issuance of the bonds of said county for the purpose of constructing a bridge across the Arkansas River^{east} of Jenks in Sections 19 and 20, Township 18 North, Range 13 East; and

WHEREAS it is now deemed advisable to repeal said resolution and not to hold said election on the date and for the amount of bonds therein set out, Now, Therefore,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS
OF THE COUNTY OF TULSA, STATE OF OKLAHOMA:

SECTION 1.

THAT a certain resolution heretofore passed by this Board of County Commissioners on the 21st day of October, 1946, entitled "A resolution authorizing and directing the calling of an election for the purpose of voting upon the question of the issuance of the negotiable coupon bonds of Tulsa County, State of Oklahoma, for the purpose of providing funds for the purpose of constructing a bridge" is hereby repealed and revoked.

SECTION 2.

THAT a certain proclamation issued by the Chairman of said Board in compliance with the requirements of said resolution set out in Section 1 hereof, calling said election to be held on the 26th day of November, 1946, is hereby set aside, held for naught and rescinded.
