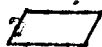

"Shall the Board of County Commissioner issue the negotiable coupon bonds of Tulsa County, State of Oklahoma in the sum of Two Hundred Eighty Thousand (\$280,000.00) Dollars to mature serially \$15,000 each year beginning 3 years from their date and \$25,000 in the 20th year and bearing interest not to exceed the rate of three per centum per annum, payable semi-annually for the purpose of constructing a bridge over the Arkansas River east of Jenks in Sections 19 and 20, Township 18 North, Range 13 East, the total estimated cost of which is Five Hundred Thirty Thousand (\$530,000.00) Dollars?"
