A motion was made by W. L. North and seconded by F. M. Wooden that the plans, profiles, specifications and estimate submitted by T. C. Hughes on the Park View Drainage District be and the same are hereby approved, and the County Clerk is hereby authorized and instructed to advertise for bids for the construction of the work in said drainage district, said bids to be received on Monday March 7th, 1921. Motion carried.

The report of the Deputy State Examiner and Inspector, Ed O. Cassidy on the audit of Lewis Cline, County Clerk, County Clerk's Division from the beginning of the term June 1st, 1917, to the close of the term was presented and approved. And it appearing from the said report that there is the sum of \$1505.84 of cash unaccounted for anddue to the county from the said Lewis Cline, County Clerk. On Motion of W. L.
