A LEASEE AGREEMENT LEASING TULSA COUNTY EQUIPMENT TO THE WORKS PROGRESS ADMINISTRATION ON CERTAIN TULSA COUNTY TOOLS AND EQUIPMENT THAT ARE OWNED BY TULSA COUNTY, FOR THE PURPOSE OF CONSTRUCTION, MAINTAINING AND OPERATING TULSA COUNTY HIGHWAYS.

Whereas, it is demed to the best interests of Tulsa County that the Board of County Commissioners enter into an agreement with the Works Progress Administration to furnish certain equipment so that the Works Progress Administration under their authority can furnish certain gasoline, oils, greases, and fuels, so that the Works Progress Administration can perform the necessary work on certain projects, heretofore entered into with the Works Progress Administration.
