Tulsa Oklahoma November 18th 1907

The County Commissioners of Tulsa County met in special session in office of County Clerk. On motion W. L. North was elected chairman of County Board. On motion of S. H. Cleveland the matter of disposing of bonds as filed in order was taken up in order. Motion prevailed. The Bond of A. H. Pyramids Justice of the Peace Iny Township on motion was approved. The Bond of John Black Justice of the Peace Tulsa Township, on motion was laid aside for stronger security. The Bond of Jake Moran constable Tulsa Township on motion was approved. The appointment of John Pritchard, P. A. Reynolds & Carl E. Page as deputy sheriffs on motion was accepted. The Bond of S. B. Parkinson, Justice of the Peace, Broken Arrow Township was on motion approved. The Bond of Henry S. Walley Register of Deeds, Tulsa County was on motion approved. The Bonds of P. H. Cleveland, W. L. North & Geo. McNeelan as county Commissioners were approved by the County Judge. The Bond of S. L. Cooper Constable Skiatook Township was on motion approved. The Bond of J. M. Stringer Justice of the Peace Skiatook Township was approved. The Bond of W. J. Brumbaugh Justice of the Peace Broken Arrow Township was on motion approved. The Bond of Geo. M. Kistow Justice of the Peace Tulsa Township was on motion approved. The Bond of A. H. Collins County Surgeon was on motion approved. The Bond of Alonzo Lewis Sheriff was on motion approved. The Bond of John A. Elephant & Chas. Haley Abstractors was on motion approved. On motion the Clerk was instructed to order the following supplies as per price made by representatives of Geo. Barnard & Co. One Will Book 400 pages One Judgment Docket. (For indexing abstracts of judgment) this book to have canvas cover extra 1400 pages. One District Court Journal 640 pages. Three units of Filing Cabinets. Bryan & Weston paper to be used, best leather backs for books. On motion Dec. 7 was set to take up all petitions of applicants for appointments and appointment offices. On motion W. L. North was made purchasing agent. On motion recess was taken until 8 A.M. Nov. 19 1907. As per above motion the County Commissioners met at 8 A.M. Nov 19 1907 all members present. On motion County Clerk was ordered to make list of such officers as are to be appointed and have same on file December 7 1907. On motion the Bond of John Black Justice of the Peace was appointed. On motion the Tulsa Democrat is made the official organ county Paper for a period of one year at one third legal rate. On motion that if the Tulsa Democrat refuses to do work at the rate named that the contract be let to the lowest responsible bidder. On motion the Bond of Charles W. Grimes was approved. On motion W. L. North was delegated power to rent office rooms to best advantage for County officials. On motion County Commissioners adjourned to meet on call of Chairman W. L. North
