WITNESSETH: For and in consideration of the mutual promises of the parties hereto as hereinafter set forth, parties hereto do covenant and agree as follows:

That WHEREAS, there is pending in the Supreme Court of the United States a certain action entitled Indian Territory Illuminating Company, Petitioner, Vs Board of Equalization of Tulsa County, Oklahoma, Respondent, No. 356, October 1932 Term, which said matter is set for oral argument at Washington, D C January 16, 1933 and in which the brief of the County Board of Equalization is due for filing January 9, 1933, and

WHEREAS, it is expedient and to the best interests of Tulsa County that second party be employed as additional Counsel, and Holly Anderson, County Attorney, has recommended the employment of additional counsel to assist in the preparation and filing of brief and in the presentation of oral argument in said cause and has recommended and does hereby recommend the employment of the party of the second part, Attorney at Law, duly engaged in the practice of law, and

WHEREAS, the said party of the second part has agreed to and does hereby accept such employment on the terms and conditions hereinafter set forth.

NOW, THEREFORE, Party of the First Part, by resolution duly passed and adopted and by these presents does hereby agree to pay or cause to be paid at this time to the party of the second part the sum of Three Hundred (\$300.00) Dollars, and the additional sum of Two Hundred (\$200.00) Dollars if and when said cause is finally affirmed by the Supreme Court of the United States, there being at this an adequate appropriation from which to pay said fee and contingent fee.

And the party of the first part does further agree to pay or cause to be paid to the second party all necessary expenses for the trip to Washington, D C not to exceed \$150.00, when receipts are presented, and to pay the cost of printing briefs in said cause. The parties hereto further agree that this Contract and Agreement shall be binding upon the successors and assigns of either of the parties hereto.
