WHEREAS, The Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to N C ORR of a deed conveying to him for a consideration of Thirteen Hundred Sixty Four (\$1364.01) and 01/100 Dollars the following described lots:
