Motion is made by Commissioner Gray, seconded by Commissioner Kinkaid, that each of said Budgets be submitted to the Excise Board for approval and that publication be made of the estimated needs as required by law. Motion made by Commissioner Greer, seconded by Commissioner Gray, that the City of Tulsa be authorized to relocate the 12 inch water line for a short distance within the right-of-way of said Tulsa-Sapulpa Union Railway Company, and that the Tulsa County Drainage District No. 12 reimburse said City the costs thereof when completed.
