

At a regularly adjourned meeting of the Board of County Commissioners held on the 23rd. day of October, 1925, the following Resolution was introduced by W L North, which motion was seconded by J S Shaver, and the Resolution ordered read:

# R E S O L U T I O N

WHEREAS, certain lands are needed for highway purposes.

THEREFORE, BE IT RESOLVED, That upon the recommendation of the County Engineer the County Attorney is hereby requested to bring condemnation proceedings against the owners, the heirs of David Gandall, Deceased, and Mrs. M C Gandall, Guardian, on the following described property, to-wit:

The North Forty Nine and five tenths (49.5') feet of the Northeast Quarter (NE $\frac{1}{4}$ ) of the North East Quarter (NE $\frac{1}{4}$ ) of the Northeast Quarter (NE $\frac{1}{4}$ ) of Section Twenty Three (23), Township Twenty One (21) North, Range Twelve (12) East, less previously owned by Tulsa County, and containing five tenths (0.5) acre.

Upon roll call, all members voting in the affirmative, the said Resolution was declared adopted and ordered made a matter of record in the Commissioners Journal of Proceedings and a certified copy thereof be transmitted to the County Attorney of Tulsa County, Oklahoma.

There being no other official business coming on for hearing, the meeting stands adjourned until, Monday, October 26th. 1925.
