R E S O L U T I O N .

The Board of County Commissioners of Tulsa County, Oklahoma, in regularly adjourned meeting, at their offices, Tulsa, Oklahoma, this the 9th. day of April, m1928, with all members present passed the following Resolution:

WHEREAS, the law provides that the County Commissioners may contract with any person or persons to assist the proper officers of the County in discovery, listing and assessing of property not assessed as required by law.

NOW, THEREFORE, BE IT RESOLVED, By the Board of County Commissioners of Tulsa County, Oklahoma, in meeting assembled, that a contract be and is hereby made and entered into with BERT C HODGES of Okmulgee, Oklahoma, to assist the proper officers of this County, in listing and assessing omitted property, after discovery by him, in accordance with the provisions of the Sections 9798 to 9801 and other Oklahoma Statutes covering the duties of a Tax Ferret but that insofar as this particular contract is concerned it is limited to the following classes of property.

Estates that are nor or have been under the control of Guardians, Administrators and Executors.

Oil Field Equipment, and Supply Houses.

and the compensation shall be fixed at fifteen percent of the amount collected under his discovery, for such services, all claims for services under this contract to be presented to this Board ofor allowance.

The following Resolution was introduced by Commissioner North, who moved its adoption; said motion being seconded by Commissioner Hedgecock, and the Chairman ordered the Resolution read:

R E S O L U T I O N

WHEREAS, for the purpose of constructing a County Highway through and across certain land in Section Twenty Three (23), Township Eighteen (o8) North, Range Twelve (12) East, it is necessary to acquire a strip of land particularly described as follows:

"Right of Way for highway purposes, being the South Thirty Three (33') feet of the SE $\frac{1}{4}$  of the NE $\frac{1}{4}$  of Section 23, Twp 18 N., Range 12 E., containing 1.0 acres, more or less"

AND, WHEREAS, Tulsa County has been unable to affect an amicable settlement in
