The County Attorney was instructed on motion to at once notify the M.H. & J.P.P. Co. to construct a good and sufficient crossing on section line between Section 16 & 17 Township 19 Range 13 east calling attention to the law in the matter. On motion it is requested that Township Road Overseers notify County Commissioners as to violation of law in regard to Rail Road crossings.
