The Acme Brick Company respectfully shows that it is preparing to build a plant for the manufacture of brick in large quantities on the South West Quarter of the SouthWest Quarter of Section 28, Township 20 North, Range 13 East, in Tulsa County, Oklahoma.

That for the purpose of loading and shipping the products manufactured it will be necessary for it to run a spur track from the Frisco Railroad to its plant, and it is contemplated that said spur track will cross the State Paved Highway between Tulsa and Dawson at a point between 250 and 275 feet Southwest from the point where the center line of the highway crosses the North and South Center line of Section 28, and that said spur track will cross the public road running North and South along the center line of said Section 28, at a point between 225 and 250 feet North of the point where the North line of the State Highway between Tulsa and Dawson crosses the North and South Half Section lines of said Section 28.

WHEREFORE, Your Petitioner prays that your Honorable Body grantto it a permit to cross said State Highway and said North and South Half Section Line road between the points indicated.
