

just and correct and remains due and unpaid.

And it is further provided that the account shall be regularly filed with the County Clerk five days before the first day of the meeting of the Commissioners, which account shall be regularly numbered in the order of filing and placed on the calendar by the County Clerk for public inspection and convenience.

A summarization of the above statutory provisions is as follows:

1. All claims, either for salaries or on accounts can only be allowed at the regular monthly meeting of the Board of County Commissioners.
2. All claims, excepting salary claims, must be filed with the County Clerk five days before the Board of County Commissioners has jurisdiction to act thereon.
3. Where County officers are required, under the law, to file a monthly report, the salary claims of the officers and deputies cannot be allowed until the monthly report is filed and approved by the Board of County Commissioners.

Section 7828, Oklahoma Statutes, 1931, provides as follows:

"The salaries of the County officers, their clerks and deputies shall be paid monthly out of the County Treasury by order of the Board of County Commissioners; Provided, however, that no salaries shall be allowed until their reports are filed and approved by the Board of County Commissioners as provided by law".

R E S O L U T I O N

WHEREAS, Tulsa County desires the opening of 15th Street from the center of Sec. 10, T. 19 N., R. 13 E., East one-half mile to Sheridan Drive.

AND, WHEREAS, it becomes necessary to remove a building from the right of way secured from property owners for this purpose.

AND, WHEREAS, it further becomes necessary to serve legal notice on Mr. and Mrs. O S James residing in said dwelling without permission from the previous property owner, namely, Claude Bailey, from whom right of way was recently secured.

THEREFORE, BE IT HEREBY RESOLVED, that the Court through its proper channel serve notice on the said Mr. and Mrs. O. S. James to vacate immediately the said building, so that construction of this project may be carried out.

All voting in the affirmative upon the adoption of the resolution, the Chairman declared motion carried and Resolution adopted.

In the matter of the application of Oklahoma Power and Water Company for permission to locate an electric pole line, the following order was made:

O R D E R

Now, On this 30th. day of January, 1933, comes on for hearing the application of the Oklahoma Power and Water Co., for permission to locate electric pole line as per plat attached to its said application, marked Exhibit "A", and made a part thereof, said electric pole line beginning at a point twenty feet (20') North of Quarter Corner between Sections Thirty Three (33) and Thirty Four (34), Township Nineteen (19) North, Range Eleven (11), East thence West and parallel to the East and West one-half section line of Section Thirty Three (33), Township Nineteen (19) North, Range Eleven (11) East, a distance of Thirty Two hundred (3200) feet at which point said electric line leaves said road.

And, it appearing to the Board, and each of the Commissioners thereof, that it is just and necessary that said application be granted, and it further appearing that said electric pole line will not interfere with any of the rights of the general public in the use of said highway, and that such electric pole line will be constructed in accordance with all lawful rules of the County Commissioners of Tulsa County, Oklahoma and all laws of the State of Oklahoma, governing same.

IT IS HEREBY ORDERED AND ADJUDGED By the Board of County Commissioners of said Tulsa County, Oklahoma, that such application be granted, and it is hereby granted to the Oklahoma Power and Water Co. and its assigns, to use as much of the highway as above designated for the purpose of constructing said electric pole line.
