NOW, THEREFORE, The Board of County Commissioners of the County of Tulsa, of the State of Oklahoma in regular session assembled and pursuant to the aforesaid statutes of Oklahoma, hereby approve the sale of said lots so made by the County Treasurer to him for a consideration of \$47.24 and it is hereby ordered that the Chairman of the Board of County Commissioners execute to him a deed conveying to him all the right, title and interest of the County of Tulsa, of the State of Oklahoma, in and to said lot and the County Clerk of Tulsa County is hereby directed to attest his signature and attach hereto the seal of this office.
