

Tulsa, Okla April 6<sup>th</sup> 1908

The County Commissioners of Tulsa County, Okla. met in regular session in the office of the County Clerk. Present G. S. McKeown and W. C. North minutes of meeting of Feb. 12<sup>th</sup> read and approved. The representation of the Vandorn Show Works Company having completed his work, the Commissioners inspected jail job and accepted same. The claim No 452 of the Vandorn Works Co. claimed for \$2592<sup>00</sup> for jail cells was allowed for \$2392<sup>00</sup>. A motion was made to amend location of bridge across Mingo on section line between Twp 8 Township 20 Range 14 east to read as follows. One bridge to be located on section line between Section 19 & 30 Township 20 Range 14 east and the bridge previously located on section line between Section 31 & 36 Township 19 Range 16 east to be located on section line between 18 & 12 Township 19 Range 13 east was adopted. On motion E. L. Estey was appointed Justice of the Peace of Lind Lane Township. On motion John J. Enos was appointed Constable of Lind Lane Township. The above appointees to make bond immediately. On motion J. P. Mitchell was appointed Clerk of Bowles Township claim No 117 J. A. Blaise for 120<sup>00</sup> Special service was allowed 120<sup>00</sup>.

On motion Commissioners adjourned to meet at 9 A.M. Tuesday April 7 1908 Pursuant to previous agreement the County Commissioners of Tulsa County, Okla met in County Clerk's Office April 7 1908. The Bond of the Oklahoma Abstract Co. was examined and on motion referred back for personal Bond.

The Bond of the Central Natl Bank as a county depository was on motion adopted and the County Treasurer was authorized to place County funds therein. The appointment of John J. Moran as Deput Sheriff was approved. The Bond of J. P. Sanders Assessor Red Fork Township was referred back for more surety. The Bond of P. H. Taylor Assessor Dawson Township, the Bond of H. C. Buck Treasurer Dawson Township, the Bond of E. A. Jewell Assessor Skiatook Township, the Bond of Amos W. Lord Trustee Owasso Township, the Bond of J. P. Foutz Assessor Lind Lane Township, the Bond of Amos W. Lord Assessor Owasso Township, the Bond of G. A. Anthony Treasurer Bowles Township, the Bond of J. O. Brown Clerk Red Fork Township, the Bond of L. S. Turley Assessor, Broken Arrow Township were on motion approved. The resignation of Ed W. Wall Constable Jenkins Township, Chas H. Tracy Justice of the Peace Jenkins Township, Jake Moran, Constable Tulsa Township, L. C. Robard Justice of the Peace, Skiatook Township were read and on motion resignations were passed for the meeting. The Abstractor's Bond of Frank S. Foster Abstractor was examined and on motion was approved. The appointment of P. Yarger Deputy Sheriff was read and on motion approved. The Bond of John J. Enos Constable, Lind Lane Township, W. E. L. Estey Justice of the Peace Lind Lane Township were on motion approved. The Commissioners took recess.
