Motion was made by Mr. North, seconded by Mr. Hedgecock, that the Petition asking for an electric line to be constructed along the Sand Springs Highway be referred to the County Attorney for advice to Commissioners as to whether or not they have a right to establish such a line on public highways. Carried.

Motion was made by Mr. North, seconded by Mr. Stuckey, that Claim No. 133357, favor of Tulsa Brace and Appliance Company be and the same is hereby disallowed for the reason that same is not approved. Carried.

Motion was made by Mr. North, seconded by Mr. Hedgecock, that the County Engineer be and he is hereby instructed to prepare plans and specifications and advertise for bids for the necessary drainage structures on Miles One (1) and Two (2), Sec. T1, Tulsa County Highway, Two (2) Miles West of Jenks.

Hearing on the formation of Water Improvement District No 8, was had pursuant to the published Notice, and detailed account of said hearing can be found in Water Journal No. 8, of the records of the County Clerk's office.

In the matter of the Petition of W R McKee for permission to lay a water line, under thru and across certain highway, the following Order was made:

O R D E R

NOW, On this 16th. day of April, 1928, in the matter of the Petition of W R McKee for permission to lay a water line under, through and across certain highways in said County and State came up before the Board of County Commissioners of said County for hearing, and it appearing to the Board and each of the Commissioners thereof that it was just that the said W R McKee be permitted to use as much of the highways as designated by the said description, which is as follows, to-wit:

A proposed two inch or less water line, beginning at a hydrant at the Southwest (SW) Corner of Section 11, T 19 N., R 12 E., thence South parallel to the Section line and on the East side of the public highway.

AND, it further appearing from the petition herein that said water line will be so constructed as not to interfere with any of the rights of the general public in the use of said highways; and will be constructed in accordance with all rules of the County Commissioners and the laws of the State of Oklahoma governing same.

IT IS HEREBY ORDERED AND ADJUDGED, By the Board of County Commissioners of said County that permission be granted, and the same is hereby granted to W R McKee, to use as much of the highways as above designated.
