Plans Drawings Report of Surveyor Viewers Notice to Property Owners as per recorded in Road Record same on motion approved. Warrant ordered drawn for amount of damages. In the matter of the Petition of McCullough, Lancaster et al wherein viewers were appointed to view road on the 9th day of March 1908 and the return of said viewers having been filed with the County Clerk and same having been read was approved as per report of Viewers said damages allowed for \$50⁰⁰ Plans Drawings Report of Surveyor and Viewers Notices to Property Owners as per recorded in Road Record same on motion approved and Warrant ordered drawn for amount of damages. The Commissioners then took up claims against County motion made that all Geo D. Barnard Bills be passed until Thursday April 9th 1908
