

deems it necessary to re-district said County into three compact Commissioners Districts.

THEREFORE, BE IT RESOLVED, By the Board of County Commissioners in legal meeting assembled that under and by virtue of the authority of the laws of the State of Oklahoma the said County of Tulsa be and is hereby divided into three Commissioners districts as follows:

DISTRICT NO. 1.

That District No. 1, in the County of Tulsa, in the State of Oklahoma, shall comprise and embrace all of the territory contained and situate within the following boundaries:

Beginning at a point at the northeast corner of Tulsa County, Oklahoma, and thence running south on the division line between Tulsa and Rogers Counties in the State of Oklahoma to the township line between Dawson Township and Lynn Lane Township, and thence running west on such township line to a point in the center of the intersection of Archer Street and Lewis Avenue within the corporate limits of the City of Tulsa in said County and State, and thence running south in a direct line in the center of said Lewis Avenue to a point in the intersection of Lewis Avenue and 6th. street within the corporate limits of the City of Tulsa in said County and State; and thence west from said point in the center of said 6th. Street in said street's course as now shown by the official records of the City of Tulsa to a point in the center of the intersection of 6th. Street and Main Street within the corporate limits of the City of Tulsa in said County and State, and thence in a direct line from said point at the intersection of said 6th. Street and Main Street in a northwesterly direction in the center of said Main Street to Haskell Street within the corporate limits of Tulsa in said County and State and thence continuing North in a direct line in the center of said Main Street to a point in the middle of the intersection of said Main Street and Pine Street within the corporate limits of the City of Tulsa; and thence West from said intersect on point in a direct line in the center of said Pine Street to the division line between said Tulsa County and Osage County, and thence North in a direct line along said division line to the northwest corner of Tulsa County, and thence East in a direct line on the division line between said Tulsa County and Washington County in the State of Oklahoma to the point of beginning.

DISTRICT NO..2.

That District No 2 in the County of Tulsa, in the State of Oklahoma shall comprise and embrace all of the territory contained and situate within the following boundaries:

Beginning at a point on the division line between Osage County and Tulsa County in the State of Oklahoma where Pine Street within the corporate limits of the City of Tulsa in the State of Oklahoma joins said division line and running thence East in a direct line in the center of said Pine Street to a point in the center of the intersection of Pine Street and Main Street within the corporate limits of said City of Tulsa, and thence direct south from said intersection point on a line in the center of said Main Street to a point where said Main Street intersects Haskell Street within the corporate limits of said City of Tulsa; and thence continuing in a southeasterly direction on a direct line in the center of said Main Street to a point in the center of the intersection of said Main Street and 11th Street within the corporate limits of the City of Tulsa and thence South in a direct line from said intersection of said Main Street and 11th Street and on a line in the center of Main Street to a point in the center of the intersection of said Main Street and 15th. Street within the corporate limits of the City of Tulsa and thence West from said point in a direct line in the center of said 15th. Street to the East Bank of the Arkansas River, and thence in a southeasterly direction in a meandering line and following said river bank to a point where the division line between the Frye and Lynn Lane Townships in said County intersect said East Bank of said River, thence West on a direct line to a point at the northwest corner of Jenks Township in said Tulsa County and thence West on the division line between Creek County and Tulsa County, in the State of Oklahoma, to a point where said division line joins the East line of Creek County and thence North on the division line between Creek County and Tulsa County, in the State of Oklahoma, to a point where said division line joins and connects with the south line of Pawnee County, in the State of Oklahoma, and thence East in a direct line on the division line
