shall conduct said Special Election shall be as heretofore officially designated by the County Election Board of Tulsa County, in the state of Oklahoma, and the regular precinct boundaries for said Tulsa County shall be as heretofore designated by said County Election Board, said precincts, the voting places therein and the Inspectors, Judges and Clerks who will conduct said special election to be the same as, and identical with the precincts, voting places, Inspectors, Judges and Clerks of the regular election to be held on the 4th. day of November, 1930.

## ORDER.
